- The purpose was to recognize state, local, tribal, and territorial (SLTT) jurisdictions who complete significant achievements during a 12-month period between Retail Food Protection Seminars





## Retail Program Standards Milestone Accomplishments (cont.)

Milestone Certificates and letters are presented to jurisdictions who achieve the following during a calendar year\* between seminars:

- Completion of an Initial Full Self-Assessment of all Nine Standards (SA9)
- Completion of a Full Self-Assessment (periodic) of all Nine Standards (SA9)
- Meeting and Reporting a Successful Verification Audit of 1 or more Standards during a current Self-Assessment Cycle
- Meeting and Reporting Successful Verification Audits of all Nine Standards during a current Self-Assessment Cycle
