The Association of Food and Drug Officials was founded in 1896. In 2024, the 128th AFDO AEC will be held in Grand Rapids, Michigan.

The AFDO AEC attracted more than 500 participants in 2023. Five days of educational sessions offered 90+ workshops, federal regulatory updates, general information sessions, and track offerings for food, retail, cannabis, produce, and body art. Sprinkled throughout were networking and award events.

The value of the AFDO annual education conference is partially conveyed by the numbers.
